however the injury or damage occurs, including, but not limited to the negligence of Messiah United Methodist Church and/or York City Day Camp its officers, agents, and employees.

In consideration of the named minor's participation in York City Day Camp I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Messiah United Methodist Church and/or York City Day Camp, its agents and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's York City Day Camp participation.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in York City Day Camp participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in York City Day Camp and that by signing this agreement I hereby, on behalf of myself and the named minor, release Messiah United Methodist Church and/or York City Day Camp, its officers, agents, and employees of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments which would preclude his/her safe participation in York City Day Camp.

I, in my legal capacity as parent/guardian of the named minor, expressly agree, on behalf of myself and the named minor, that this document is intended to be as broad and inclusive as permitted by the law of Pennsylvania and that if any portion of the document is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Furthermore, I expressly agree that this document shall be governed by and interpreted in accordance with the laws of Pennsylvania and that the courts of York County, PA shall be the exclusive venue for any and all disputes relating to or arising from this document.
